

## Emergency Housing Message - Hurricane Michael

### Owners and Management Companies:

Severe and potentially dangerous weather conditions are expected to hit the Southern Georgia region this afternoon. Based on the latest forecast for Hurricane Michael and acting on a recommendation from GEMA/HS officials, Governor Deal today issued an [emergency declaration for 92 Georgia counties](#). It is our hope that you, our residents, and your families will be safe during this time.

In preparation for Hurricane Michael, we are sending the following interim announcement:

1. Please be sure that occupancy information for all of your properties are currently updated in Mitas. Georgia may receive storm victims from Florida, in addition to our own residents, that could be in need of temporary housing.
2. Please be sure your property information is current on Georgia Housing Search, [www.georgiahousingsearch.org](http://www.georgiahousingsearch.org). This website serves as a resource for those in need of permanent and temporary housing.
3. If your property has an inspection scheduled within the next few days, your inspector will reach out to the property directly to reschedule, as needed. DCA will send additional updates via the Blast, as needed. Questions, property updates, and requests should be mailed to: [Compliance@dca.ga.gov](mailto:Compliance@dca.ga.gov).
4. If your property incurs damage due to Hurricane Michael, DCA may be able to provide technical assistance. Please email [Compliance@dca.ga.gov](mailto:Compliance@dca.ga.gov) for further assistance. Additionally, please read our next scheduled Blast on the 15th of October, to follow the correct procedure for reporting Casualty Loss.
