



WaterFirst: Recognizing Communities for Excellence in Water Stewardship

What is WaterFirst?

- Voluntary partnership between local governments, state agencies and other organizations working together to enhance the quality of life through the wise management and protection of water resources;
- Proactive approach to water resources connecting land use and water quality and quantity;
- Approaching water resources beyond political boundaries, recognizing the links of shared water resources in a watershed;
- Pursuing and rewarding environmental excellence **beyond** what is required by law; and
- Establishing a network of water professionals and leaders in the industry; and
- Protecting valuable water resources for both environmental and economic benefits today and for future generations.

Some communities may already qualify for designation and recognition as WaterFirst, having met specified criteria, while others will require assistance in addressing the complex and challenging water issues that exist within their region. There are seven major components of the WaterFirst Program and the extent to which the participants have demonstrated they have addressed each one based upon their size and the water-related services they provide will determine if they are designated a WaterFirst Community or selected to participate in the WaterFirst class (a group of communities striving to achieve the designation). The seven WaterFirst components are:

- Watershed Assessment;
- Stormwater Master Planning;
- Water Supply Planning;
- Water Supply Protection;
- Water Conservation;
- Wastewater Treatment Systems and Management; and
- Water Reclamation and Reuse

Participation Benefits

- Resources, tools, and support to help meet water management goals.
- State-wide recognition for being environmental stewards.

Designation Benefits

In addition to the Participation Benefits, designated communities receive:

- A 1% interest rate reduction for Georgia Environmental Facilities Authority water related loans.
- Annual eligibility for DCA Community Block Development Grants for water related projects
- Priority for EPD 319 Grant funding;
- State-wide recognition, including road signage and authorization to use the WaterFirst trademarked logo.

- Monitor, maintain, and improve our stormwater infrastructure through land inspection & stormwater design standards, drainage improvement projects, and a regular maintenance schedule of public streets and storm drains.*
- Develop comprehensive watershed management plans for the 17 watersheds located within Athens-Clarke County.*

Water Conservation: Maintain and build on the significant achievements that resulted from the community's drought response.”
