Date: June 29, 2006

The purpose of this memo is to update you on this year’s awards under the Supportive Housing program. As you will recall, the broad purpose of these programs is to deliver supportive housing and related services to persons strictly defined as either: (1) “homeless” according to the federal Emergency Shelter Grants (ESGP) program; or as (2) “eligible persons” (lower income persons with HIV/AIDS) as defined for the Housing Opportunities for Persons With AIDS (HOPWA) program. Portions of HUD Homeless Management Information Systems (HMIS) funds allocated to DCA, but reserved for provider agencies, are also awarded through this process.

This year, we received 184 applications requesting \$11.2 million dollars. With available Housing Trust Fund (HTF) ESGP, HTF Matching, Federal ESG, HTF Technical Assistance, Federal HOPWA, and Federal HMIS funds, we were able to award funds to 174 agencies totaling \$6.4 million dollars. The table below summarizes this year’s requests and allocations.
