



1st Quarter 2014 Performance Report

HomeSafe Georgia is a statewide program designed to prevent foreclosure due to unemployment, under-employment or other types of financial hardships. The program is funded by the U.S. Treasury Department and is housed at the Georgia Department of Community Affairs (DCA).

In the first quarter of 2014, 4,935 individuals and families in 124 of Georgia's 159 counties have received approximately \$71 million in temporary mortgage assistance through HomeSafe Georgia. As of March 31, \$96 million was committed to future payments on approved loans.

New Marketing Efforts Aim to Reach More Homeowners


To raise awareness of expanded eligibility for HomeSafe Georgia, a statewide advertising program began in March with new 15- and 30-second radio advertisements publicizing the program's website and phone number on 150 stations.

In the second quarter, marketing programs will be expanded to include public transit in Atlanta, Augusta, Columbus and Savannah markets with advertisements on buses, trains, train stations and bus shelters. New radio outreach will be initiated through targeted ad buys and PSAs, website SEO techniques will be refined.



Media relations continues on an ongoing basis, and HomeSafe Georgia continues to work with the Georgia Department of Labor, the Workforce Development Division and other public and private partners to contact potential recipients directly.

Applications Decided:

During the 1st Quarter of 2014 HomeSafe decided 1,102 applicants while 425 applications were withdrawn.

Program specific data is separated into reporting tabs for each individual program. State HFAs should report program performance data on an individual program basis. A data dictionary has been provided to assist in the definition of each data point.
