**SUBJECT:** State FY 2015 Emergency Solutions Grant, Shelter Plus Care Matching, and Shelter Plus Care Harm Reduction Awards

**DATE:** July 16, 2014

The State of Georgia is pleased to announce the selection of funding recipients under the State FY 2015 Emergency Solutions Grant, Shelter Plus Care Matching, and Shelter Plus Care Harm Reduction programs. Across all three programs, DCA received 290 requests totaling over \$12.8 million. Of these requests, DCA has awarded over \$6.6 million to organizations which will implement 218 programs to serve individuals across Georgia who are homeless or threatened with homelessness. Funding for each award comes from either (1) the Federal Emergency Solutions Grant Program or (2) the State Housing Trust Fund for the Homeless. A synopsis of the program awards is provided followed by an alphabetical listing of all awards.
