Owners are required to email DCA a copy of the Final 8609s once the forms have been filed with the IRS. A Final 8609 should have both Part I and PART II completed and signed, including all owner elections in Part II. Once you have prepared a Final 8609, email the form to Review.Submissions@dca.ga.gov with the property name and Georgia ID number in the subject line.

HOW TO SAVE YOUR ONLINE FORM BEFORE SUBMISSION

DCA uses an online company 'JotForm' to electronically receive information for requests such as *Casualty Loss* reporting and the *Annual Owner Certification*. Once a JotForm is submitted, a receipt email is sent out by DCA. Many people have asked DCA how a JotForm can be saved prior to submitting the form to DCA. **Here's how**:

At the end of the form, you have the option to print. Click 'print' and in the print dialogue box you have an option of printers or devices to choose, from that selection you can choose "Adobe PDF". You will be prompted to choose a file name. The JotForm that appears on your screen will be saved in the folder you chose.

Placed In Service Notification to DCA

To sign up for this DCA Compliance Blast, click here and join our email group for updates!

DCA should be notified using the **Placed In Service Notification** no later than 30 days after the first building in your development is placed in service. The required notification form can be found on the **Compliance Monitoring** site, select the "Form" icon.

The form includes instructions for setting the development up in MITAS and obtaining initial access to MITAS for the property. For questions about the form or set up, send your email to compliance@dca.ga.gov.
