2019 HOME RENT REVIEW

The submission deadline for the 2019 HOME Rent Review Approval form was **September 30th, 2019**.

FILE AUDITS: PRE-AUDIT DOCUMENTS

When submitting your pre-audit documents for your upcoming file audit, please submit the <u>current and previous</u> Rent Sources and Utility Allowances in use for your property. This will help our team ensure efficient review of the files and reduce the likelihood of erroneous non-compliance findings on the Notice of Deficiency report.

Include multiple pictures of the available units for each unit size available and consider showcasing common areas, features, and amenities within your site. DCA requires pictures of the interiors for each unit size on your GHS listing.

Portfolio Management Pod teams will be checking listings to determine if required pictures have been added.

DCA should be notified using the Placed In Service Notification no later than 30 days after the first building in your development is placed in service. The required notification form can be found on the **Compliance** Monitoring site, select the "Form" icon.


