ANNUAL OWNER CERTIFICATION

We are working to publish the 2019 AOC form to our website by December 31, 2019. The deadline to submit your 2019 AOC is March 2, 2020. Please refrain from using any previous versions of the AOC, at this time. We will notify all partners when the updated form is available.

ALERT: UNIT TYPE DEFINITION CHANGES

Please note HUD'S definition of unit type listed below and as found on the <u>Utility</u> Allowance site:

- Single Family Detached (one family under one roof)
- Semi-Detached (duplex, attached on one side)
- Rowhouse/Townhouse (attached on two sides)
- Low-rise apartment building (4 stories or fewer)
- High-rise apartment building (5 stories or more)
- Manufactured Home (mobile home)

DCA should be notified using the **Placed In Service Notification** no later than 30 days after the first building in your development is placed in service. The required notification form can be found on the **Compliance Monitoring** site, select the "Form" icon.
