Disaster Damage:

The Unmet Needs Assessment was used to evaluate the three core aspects of recovery - housing, infrastructure (which includes public facilities and services), and business. The remaining unmet need was calculated by first estimating the portion of need likely to be addressed by insurance proceeds, other federal assistance, or any other funding source by using the most recent available data. Those estimates are based on best available data at that time and may be adjusted in the future as additional data becomes available. After accounting for funds already made available through state and other federal assistance and other funds, the remaining estimated unmet need is approximately \$444,732,396. The federal allocation of \$41,837,000 million is going to allow the State of Georgia to address 9% of the estimated unmet need remaining. When examining the relative need by sector, business represents the greatest unmet need of \$250,476,562 (56%) of need, followed by the housing sector with \$132,935,144 (30%) of need, followed by the infrastructure sector with \$61,320,690 (14%).

Recovery Needs:

HUD identified the Most Impacted and Distressed (MID) Zip code as 39845 (Seminole County) for Disaster 4400. DCA's needs analysis confirmed that additional MID areas were located in Zip codes 31705 (Dougherty County) and 39819 (Decatur County). DCA submitted a MID Expansion Request to HUD on April 14, 2020. This request was approved on July 16, 2020. Based upon Federal Register Notice 85 FR 4681, DCA will expand operations from the MID Zip codes to include the entire county (Decatur, Dougherty, & Seminole).

Counties eligible for funds are: Baker, Calhoun, Clay, Crisp, Decatur, Dougherty, Early, Grady, Laurens, Lee, Miller, Mitchell, Randolph, Seminole, Sumter, Terrell, Thomas, Tift, Turner and Worth.

Based upon the needs assessment, DCA will utilize the funds for administration, planning, housing needs, small business

economic revitalization, workforce development, and infrastructure.

2018 CDBG-DR Allocation

This Quarterly Performance Report (â¿¿QPRâ¿) describes the CDBG-DR activities taking place in Quarter 3 of 2022 (July 1, 2022, to September 30, 2022). The State of Georgia has allocated funds to administration, planning, a Homeowner Rehabilitation and Reconstruction Program (â¿¿HRRP), a Workforce Development (â¿¿WFDâ¿) Program, a Small Business Program, and a competitive Infrastructure Program.

Planning funds in the amount of \$4,183,700 have been allocated to the State for planning purposes internally. DCA has partnered with the Georgia Emergency Management and Homeland Security Agency (GEMA) to fund a planning project to create Disaster Recovery and Redevelopment Plans (DRRPs) for each of the 20 eligible communities affected by Hurricane Michael in 2018. Additionally in Quarter 4 of 2021, DCA selected to set aside a small percentage of its planning dollars to develop a website that will serve as an online, historic commercial building registry for the downtown areas within the 20 counties, to be called DowntownGA.

Homeowner Rehabilitation and Reconstruction Program (â¿¿HRRPâ¿)
The HRRP is designed to assist homeowners of single-family properties that were damaged by Hurricane Michael in 2018. Homeowners may be eligible for rehabilitation or reconstruction of stick-built homes, replacement of manufactured homes, and/or elevation assistance. \$10,459,250 was originally set aside for this program, but DCA is awaiting HUDâ¿¿s approval for a substantial amendment to the 2018 Action Plan, which will increase the amount to \$13,248,383. Workforce Development (â¿¿WFDâ¿) Program

The WFD Program is designed to boost long-term recovery by supplying residents of the 2018 hurricane-impacted communities with the skills needed to increase household income. \$8,367,400 has been set aside for this program. The state has partnered with another state agency, the Technical College System of Georgia (â¿¿TCSGâ¿) and four of their colleges to create a program that includes training and job readiness and career services, such as job placement and support services such as childcare and transportation. This total award is \$7,867,400 of the WFD budget. Infrastructure Program (Competitive)

The State of Georgia has allocated \$8,367,400 to a competitive application process for its Infrastructure Program. However, if the previously referred to substantial amendment is approved by HUD, the total amount will be increased to \$13,945,667. This competitive round will be available to all 20 eligible counties affected by Hurricane Michael in 2018, with eighty (80) percent of funds being dedicated to the Most Impacted and Distressed (MID) areas: Decatur, Dougherty, and Seminole Counties

Additionally, the vendor is working on outreach in the impacted areas and is currently beginning the act of canvassing through phone calls and placing advertisements in local newspapers. In the new year, Workforce Group will begin the process of procuring a architectural and engineering firm to develop structural designs.

This activity will serve as the primary activity for the Workforce Development program. The Technical College System of Georgia will serve as the implementation agency and will allocate funds to the four (4) technical colleges in Southwest Georgia. Workforce Development ("WFD") Program

The WFD Program is designed to boost long-term recovery by supplying residents of the 2018 hurricane-impacted communities with the skills needed to increase household income. \$8,367,400 has been set aside for this program. The state has partnered with another state agency, the Technical College System of Georgia ("TCSG") and four of their colleges to create a program that includes training and job readiness and career services, such as job placement and support services such as childcare and transportation. This total award is \$7,867,400 of the WFD budget.

During the quarter, WFD Program staff continued to engage with prospective and current students along with community partners. The Director attended regular standing meetings to discuss the details of grant requirements, answer questions and to learn more about other opportunities leading to the recruitment of eligible students. Likewise, the case managers at both colleges attended several meetings and/or forums hosted by community partners and/or their respective colleges. Most of this quarter was dedicated to the Registration process by way of processing applications and tuition vouchers for students who were approved and attending internal meetings and training. Some of the outreach activities and meetings included the Salvation Army, Future Stars Healthcare event, Family Connections, Chamber of Commerce meetings, One Stop partner meetings, First Generation event, ATC Strategic Planning session, 100 Women Who Care event, and the Rebuild Orientation Session.

Albany Technical College ("ATC") had a large number of students graduate during the quarter. In total, 43 students graduated and 42 of those left the college employed. In total, approximately \$2 million has been obligated to students enrolled in the program.
