The only way an NCS in a PJ will be considered is if there is a commitment from the PJ to the NCS Organization/Agency to participate. If there is no commitment to the NCS from the PJ, the NCS application will fail Threshold and not be considered.

Readiness to Proceed

If the NCS project consists of rehabilitation or new construction (with or without acquisition), the NCS awardee must begin construction within 12 months of the date DCA conditionally commits funds to the project. Can the proposed project meet this requirement?

If the NCS project consists of the acquisition of a property without rehabilitation or new construction, the NCS awardee must begin project operations within 6 months of the date DCA conditionally commits funds to the project. Can the proposed project meet this requirement?

All HOME funds must generally be expended, and all development activity completed within three (3) years of DCA's contract start date. "Completion" is defined as all construction activities being completed, all development funds expended, all final inspections have taken place, and certificates of occupancy issued. Can the proposed project meet this requirement?
