Mitigation Needs Assessment:

2017 CDBG-MIT

In order to determine mitigation needs, DCA developed a pre-application to gather project specifics. The pre-applications serve as a tool, similar to a survey, for local governments to communicate their mitigation needs to DCA. All local governments located within the 15 eligible counties were invited to participate. DCA placed the pre-application on the official CDBG-MIT webpage and held two webinars to discuss questions related to the CDBG-MIT funding, the pre-application process, and to gather feedback. DCA staff explained topics such as eligibility, maximum application submission, leverage, the new Urgent Need Mitigation national objective, and other requirements of 84 FR 45838. Each local government could submit up to three (3) pre-applications.

A total of 54 Pre-Applications were received from the local governments within the 15 county area. These applications came from 23 local governments, with six (6) joint applications. The following table breaks down the financial section of the Pre-Applications. The total CDBG-MIT funds requested is \$149,242,775. Leverage was committed in 33 of the 54 Pre-Applications and totaled \$24,024,368. Of the Pre-Applications submitted, the average amount of leverage was 14% of the total project cost.

2018 CDBG-MIT

To determine mitigation needs in the MID areas, DCA staff created a Mitigation Needs Assessment Survey to collect data on priority mitigation activities within the communities. All MID county governments, as well local governments within the counties, were notified of this survey and received the link to the form via email. The recipients were given two weeks to complete the assessment. The survey form was prefaced with a notice describing the intent of the assessment, as well as a disclaimer stating that completion of the form would not result in funding. The survey The survey itself was broken up into four sections, which included a contact information sheet and three sections dedicated to one mitigation activity per section. The eligible governments were encouraged to use the latter three sections to highlight priority mitigation activities. The following details were requested for each activity:

- Activity Title
- Estimated Cost of Activity
- Hazard to Be Mitigated Against (i.e., Flood, Wind, Tornado, Seismic, or Other) •
- Critical Facility Status
- Activity Description

 National Objective of the Activity (Benefit to LMI or Urgent Need)
 A total of five completed survey forms were received following the two week-period, two of these forms being from Seminole County and its county seat, the City of Donalsonville. While Dougherty County has the highest cost estimate(s), this county is eligible for infrastructure funding through both the 2017 and 2018 CDBG-DR allocations. These funds, though not specifically designated for mitigation activities, may be used for such. As a result, Seminole County, which has the second highest total of \$4,075,000, was selected as the sole recipient of 2018 mitigation funding from DCA.



Proposed Use of Funds:

2017 CDBG-MIT

Using CDBG-MIT funds, DCA seeks to assist communities with undertaking activities that will reduce their risks posed by disasters. Many communities relied on local funds to recover from the storms of 2017, reducing their ability to spare the funds to prepare for the inevitable next disaster event. DCA seeks to collaborate with other state agencies and will also work with local governments to build on-going resiliency strategies for a more targeted investment. All planning activities with both state and local partners will fit within the guidelines proposed in Federal Register Notice 84 FR 45838. The proposed activities will incorporate, where applicable, appropriate mitigation measures and floodplain management. The activities will also promote sound, sustainable long-term recovery planning informed by a pre and post-disaster evaluation of hazard risk. In addition, planning activities will include construction standards and land-use decisions that reflect responsible floodplain and wetland management and consider continued sea level rise. The following sections detail proposed planning activities and DCA's collaboration with other state agencies, local governments, and non-profit organizations.

Direct Allocation to Seminole County for Infrastructure Mitigation:

As demonstrated by the data collected through the Mitigation Needs Assessment Survey, a majority of the MID counties and the local governments within them, specifically Seminole County, have various mitigation needs for public infrastructure, including facilities, communications, roads and bridges, stormwater, and water and sewer. These activities will be eligible under DCA's 2018 CDBG-MIT Infrastructure Program. As a note, these activities are also listed as eligible activities in the 1974 Housing and Community Development Act (HCDA). Due to the limited amount of funding available and the high concentration of damage, DCA will directly allocate the 2018 CDBG-MIT Infrastructure funding to Seminole County.

CDBG-MIT Allocation

This Quarterly Performance Report (â¿¿QPRâ¿) describes the CDBG-MIT activities taking place in Quarter 1 of 2023 (January 1, 2023 to March 31, 2023). The state of Georgia has allocated funds to mitigative planning, as well as competitive and noncompetitive infrastructure programs for the 2017 and 2018 allocations, respectively. 2017 CDBG-MIT Planning

Planning funds in the amount of \$4,044,150 will be used by the state for planning purposes internally. In addition, DCA has awarded five local government subrecipients, totaling \$2.7 million. 2017 CDBG-MIT Infrastructure

DCA has obligated a total of \$21.5 million of its mitigation funding towards an infrastructure program. This program will assist communities within the 2017 impacted areas with enhancing infrastructure in order to mitigate against future natural disasters.

2018 CDBG-MIT (Infrastructure)

DCA has obligated \$2,535,550 to this noncompetitive infrastructure program, which will directly provide funding to Seminole County, Georgia. This county sustained incredible damage during Hurricane Michael in 2018, and due to its economic state, has been recovering more slowly than the other MID areas and affected counties.

Albany then contracted with iVueit, an Ohio-based firm, to conduct the property assessments of all residential lots in the city and upload the data into an online database, which they are to develop as well. As of Quarter 1 of 2023, the City was awaiting the new, revised list of the 1,700 parcels from the vendor. Additionally, the Subrecipient requested to extend the grant deadline to July of 2023 and add a Planning Consultant to the scope of work for the activity. This amendment was approved by DCA and now Albany staff plans to submit a financial report which will cover the time spent on the planning activity to date. The City's procurement team is currently reviewing the RFP for the consultant.

• Work with local Mit Planning governments to survey the condition of property ownership in target areas. Based on survey results, the Plan will include strategies for title remediation pre- Natural Disaster.

• Work with Mit Planning communities to identify prevalence of Estate Planning. Based on results, the Plan will include strategies for increasing access to proper Estate Planning.

• Identify information gaps regarding heirs property and preparing legal documents for safe-keeping during



natural disasters. Based on results, the Plan will include strategies to increase residents' understanding of particular legal documents (deeds, wills, power of attorney, health care directive, insurance, and other documents that are needed to prevent loss of life and property), and how to store them and/or replace before, after, and during a natural disaster.

Quarter 1 of 2023, the NASA Develop Program completed its project to look at Heirs Property Prevalence and Vulnerabilities in the target area:

NASA DEVELOP

The Center received services from the NASA Develop Program (under NASA's Applied Sciences Program) between September 2022 and March 2023. NASA Develop addresses environmental and public policy issues through interdisciplinary research projects that apply the lens of NASA Earth observations to community concerns around the globe. The partnership between NASA Develop and the Center focused on identifying areas in the 15 county target area vulnerable to future disasters due to heirs property. The Center held bi-weekly meetings with NASA Develop team members. In addition, the Center hosted a joint meeting with NASA

DEVELOP and the Department of Community Affairs CDBG-DR team and DCA's GIS Specialist participated in additional meetings with the NASA team. The NASA Develop team produced maps using Land Satellite imagery for flooding and developed code to add information from CAMA data on potential heirs properties. The Center is waiting for the NASA Develop's data to go through NASA Export Control for official use in the Center's Mitigation Plan document. Preliminarily, the NASA Develop team identified over 432,174 potential heirs properties in the target area. When the Center used NASA Develop's results to estimate the tax appraised value of probably heirs property for the entire state, the amount was over \$47 billion (a dramatic increase over the \$34 billion estimate from 2017).

The Center has continued conducting Heirs Property Disaster Mitigation and Estate Planning Listening Sessions with service providers serving the 15-county target area. Overarching agencies for Quarter 1 of 2023 included: Georgia Emergency Management Agency (GEMA)

The center continues to attend Georgia Disaster Housing Taskforce meetings (the sixth meeting was on January 23, 2023). In addition, the Center was invited to participate in the Georgia State Hazard Mitigation Strategy - Vulnerable and Underserved Populations Workshop at GEMA headquarters on March 20, 2023. GEMA is looking to identify and address the mitigation related needs of Georgia's most vulnerable citizens and communities as it updates its Georgia State Hazard Mitigation Strategy. The Center's information has been shared with GEMA's External Affairs unit and a followup meeting was held with GEMA's Hazard Mitigation Planners. Taking DCA's Heirs Property initiative as an example, GEMA would like to explore using Title Clearing services to help properties participate in FEMA's land buyout program. Another meeting is scheduled for June 1, 2023.

Southwest Georgia Housing Taskforce

The Center facilitated a Mitigation Planning discussion with the Southwest Georgia Regional Commissio's Affordable Housing Taskforce on January 10, 2023. The taskforce includes affordable housing agencies and government officials; 16 representatives and officials from across Southwest Georgia participated in this discussion and the Center has held several follow up discussions since this worksop.

Georgia Housing Counseling Agencies

The Center presented "Everything housing counselors want to know about heirs property consequences and prevention" on January 23, 2023 to Georgia's 53 HUD Certified Housing Counseling Agencies. DCA sponsored the workshop and contracted the Center to produce an

educational video on Heirs Property and Estate Planning for clients of Georgia's Housing Counseling agencies. Proper Estate Planning is a critical component of Disaster Mitigation Planning and the Center was able to reach Housing Counselors across Georgia. There were 55 registered participants, and a survey was sent out January 31, 2023, to learn what additional information the Housing Counselors need. In the post-workshop survey, one

participant reflected. "I found that webinar very informative. The presenters were very well prepared and explained things so they could be understood." In addition, the educational video featuring Center staff on Heirs Property and Estate Planning for clients of Georgia's Housing Counseling agencies was emailed to Housing Counselors on January 31, 2023. Georgia Public Library Directors' Meeting

The Center was invited by the State Librarian and Vice Chancellor for Libraries & Archives, to present to the Directors of Georgia's libraries on the Center's Mitigation Planning and Signing Day work. The presentation was attended by 20 directors. Contacts were made with

directors from areas impacted by Irma and Michael.

Georgia Initiative for Community Housing The Center presented a webinar "Community Resiliency Through Property Rights: Addressing Heirs Property for Neighborhood Revitalization & Disaster Mitigation Planning" to GICH communities on April 29, 2022. There were 63 attendees spanning Georgia from Hall County to Dougherty County.

National Association of Realtors (NAR) and Georgia Association of Realtors (GAR)

The Center held a meeting with NAR on January 18, 2023 to discuss housing stability, disaster mitigation, and estate planning. Through that meeting, NAR introduced Center staff to the GAR's Director Jeff Ledford. The Center will be working with GAR and NAR on educational materials for Georgia Realtors as well as a possible Continuing Education Course for early 2024. County specific outreach in Quarter 1 of 2023 included:

Berrien Countv

In partnership with Golden Triangle RC&D, the Center participated in a Climate, Families, and

Beyond workshop on January 12, 2023. Over 25 community members gathered for this event. The Center presented information on heirs property, Disaster Mitigation Planning, and proper estate planning.

Cook County Probate Court

Center staff met with community leaders on November 17, 2022 in Adel. Community leaders included stafffrom the City of Adel's Housing Department, the Superior Court Judge for Berrien County, and attorneys from Cook County. Participants discussed issues with heirs property which were preventing the city from fulling utilizing CDBG funds to address blight and repair homes. Community leaders were also interested in creating more access to Estate Planning services. They are interested in hosting a few larger listening sessions with the legal community and elected officials in 2023.



Mitigation Through Signing Days:

The Center continues to set up Signing Days. The Center held a virtual Signing Day on January 10th with help from volunteers at Brunswick-Glynn County Library to complete Brunswick/Sapelo Island Estate Plans. Center staff partnered with Brunswick-Glynn County Library and members of the Brunswick Chapter of Links, Incorporated.

In August of 2021, the City of Albany began work on their MIT funded project, which was awarded \$3,921,402 by DCA after reviewing their application. The project encompasses improvements to sewer and stormwater



infrastructure for the city's 8th Avenue Basin (Phases I and IV). A Notice to Proceed was issued on March 20th, 2023, for Phase I of the 8th Avenue Basin Project. This contract will run for 180 calendar days. A Variance for Norfolk Southern Railway was approved on February 20th, 2023, for Phase IV of the 8th Avenue Basin Project. Norfolk Southern Agreement for execution received by the City of Albany on March 13th, 2023. It is anticipated that the GDOT permit to bore under N. Jefferson Street will be issued without delay. We also anticipate that the E&S and Land Disturbance Permits will be issued without delay. The 8th Avenue Phase 4 Plan was resubmitted to the Georgia State Historic Preservation Division on February 20, 2023, due to the substantive redesign of the Tift Park sanitary sewer lift station.
