

# 2024 QAP Listening Sessions

# Overview

DCA plans to publish drafts of the 2024 QAP in late summer and early fall of 2023. Prior to publishing drafts, DCA will hold listening sessions to help inform priorities for the 2024 QAP. Listening sessions are an opportunity for members of the public to raise any issues and recommendations related to the topic of the session. DCA will also provide an overview of key questions and potential policies staff are investigating related to each topic. "General" sessions are not restricted to specific topics.

- All sessions, with the exception of the virtual session on 6/1, will be held in downtown Atlanta at the Georgia Municipal Association (GMA) building.
- Location and parking information will be provided to those registered to attend in person. GMA will not admit into the building individuals who are not registered.
