G2417.6.2 (404.15) Outlet closures. Gas outlets that do not connect to appliances shall be capped gas tight and protected from damage.

REASON/INTENT: Existing section G2420.1.3 (409.1.3) requires valves to be protected from damage. For the most part no one is protecting the valves from damage. Protecting the valve from damage is extremely important and needs to be included in other sections to emphasize the requirement.

For those that have been complying with the code no additional cost will be incurred.

REASON/INTENT: Failure to protect appliance valves from damage as required by Section G2420.1.3 & (409.1.3) has resulted in several explosions in the last 5 years.

FINANCIAL IMPACT OF PROPOSED AMENDMENT: No cost in locating valve 15 inches above finish floor. Physical barrier could be as simple as attaching a 2x4 to the wall to prevent the clothes dryer when moved or replaced from damaging or accidental activation of the valve.
