2021/2022 QAP DCA Approved Construction Compliance Inspector List Construction Monitoring and Compliance

Construction work must adhere to the standards and requirements contained in the Qualified Allocation Plan (QAP), the respective DCA Architectural program manuals, the Application, Land Use Restrictive Covenant, or Land Use Restriction Agreement, and all manufacturers recommended installation procedures and guidelines for all materials used during the construction of the project.

For ALL "non-GHFA" funded projects (i.e., 4% LIHTC/Bond and 9% LIHTC funded projects), Owners must contract with a DCA-approved "Construction Compliance Inspector" to perform monthly inspections and complete reports in accordance with the DCA inspection form.

Reports must address any concerns pertaining to construction quality, safety, and progress. Reports for rehabilitation projects must also address any concerns pertaining to resident safety and treatment of resident belongings. DCA reserves the right to request such reports, but these need not be submitted monthly to DCA.

The Owner's "Construction Compliance Inspector" must approve all draw requests. The Owner's "Construction Compliance Inspector" must return to the site in the below timeframes to confirm issue resolution:

- Issues identified in a monthly inspection report related to site safety, resident safety, and treatment of resident belongings must be resolved within 48 hours.
- Issues identified in a monthly inspection report related to construction quality must be resolved within three (3) months.
