#### Lumber Bill HB 132

Ted Miltiades informed the SCAC that the DCA attorneys reviewed HB 132 and stated that the bill does not apply to commercial buildings. Therefore, the bill will be assigned to the 2024 IRC Task Force.

Mike Barcik and Amelia Godfrey presented proposed amendments to the 2015 International Energy Conservation Code, Sections R403.3.2, R403.3.3, and R403.3.4.
