





Balance of State Continuum of Care

HUD Continuum of Care

A Continuum of Care (CoC) is established by representatives of relevant organizations within a geographic area to carry out the responsibilities set forth in the CoC Program interim rule.

Georgia Balance of State CoC has 152 counties.



HUD Continuum of Care Program

The CoC Program is designed to assist individuals and families experiencing homelessness and to provide the services needed to help them move into permanent housing, with the goal of long-term stability.

- ☐ To develop a long-term strategic plan and manage a year-round planning effort that addresses
 - the needs of homeless individuals and households;
 - the availability and accessibility of existing housing and services; and
 - the opportunities for linkages with mainstream housing and services resources.
- ☐ To prepare an **application** for McKinney-Vento Homeless Assistance Act (McKinney-Vento) competitive grants.
- ☐ To have an independent Board of Directors, maintain a written Governance Charter, set and meet goals to prevent and end homelessness, and implement all other requirements of the HEARTH Act


Collaborative Applicant (DCA) Responsibilities

- To provide oversight for the Continuum in order to meet HUD's rule for Continua of Care and to assure that requirements are met for the annual HUD Continuum of Care funding competition.
- Maintain Continuum membership lists, conduct membership recruitment campaigns targeted to stakeholders, publish agendas for membership meetings, and assist the Board in conducting meetings of full membership not less than twice annually.
- Consult with both ESG Entitlements and HUD Consolidated Planning jurisdictions.
- Implement and coordinate the biennial unsheltered point in time count and the annual shelter survey.
- Provide staff for planning and implementation of HEARTH Act requirements and overall CoC strategies

Membership

- Formalized process
- Agency representation and individuals
- Voting Designated voting member (agencies only)
- Participation Code of Conduct Policy approved May 19, 2021
 - Attend not less than one meeting (membership, Board, Committee, or Subcommittee) per year
 - Agencies can substitute staff for meeting participation
 - Inactive or non-voting members to be reviewed
- CoC-funded providers are expected to participate (membership & attendance)

2021 Balance of State CoC Competition Priority Ranking Submitted to HUD

- 70 project applications received
- Applications divided into 4 groups for review
- Application reviews conducted by third parties
- Staff conducted performance reviews for renewal projects (based on data)
- New project reviews based on organization capacity, project design, and eligibility
- Board approved results of the competition, final ranking and determinations, and recommended reallocations of the 2021 Balance of State CoC Competition (as recommended by the Standards, Rating & Project Selection Committee)

2021 Balance of State CoC Project Funding Requested (cont'd.)

- No additional projects proposed for reduction or reallocation
- Of 6 new projects submitted (7 in e-snaps), 2 (3 in e-snaps) did NOT meet threshold


2021 Balance of State CoC Project Funding Available Versus Amount Requested

Funding Available to Balance of State CoC

- □ CoC Bonus (5% of PPRN) \$1,192,227
- DV Bonus (15% of PPRN) \$3,576,680
- Estimated Total = \$24,274,045


Project Funding Requested:

- □ Tier 1 & Tier 2: \$19,505,138
- □ DV Bonus: \$249,010 (current without adjustments)
- □ Project Total: \$19,754,148
- □ CoC Planning (non-competitive): \$715,336

2021 Balance of State CoC Competition (cont'd.)

- CoCs cannot receive bonus funds unless they demonstrate that projects are evaluated and ranked based on the degree to which they improve system performance.
- HUD prioritizes funding for CoCs that demonstrate ability to reallocate lower performing projects to higher performing projects.
- Alignment with CoC and HUD priorities


Balance of State CoC Role

- ☐ Facilitation of the scoring and ranking of project applications
- ☐ Grants are administered directly by HUD

Federal Funding Availability

- Based on the Annual Renewal Amount
- ☐ Tiered Approach for Project Ranking*
 - Tier 1 = typically 94% or more of funding available to the CoC
 - Tier 2 = difference between Tier 1 and max amount of renewal, reallocation & CoC bonus

Bonus funding typically available, provided appropriate high-scoring new project applications are submitted



2021 Project Scoring

Organization Review - Agency Capacity

- Renewal projects Project Threshold Criteria
 - Agency demonstrates they have capacity to carry out and implement the project proposed. Eligible renewing projects are considered to have met threshold unless other information is available to the contrary.
- New projects
 - ☐ Agency demonstrates they have the capacity to carry out and implement the project proposed. (BoS 20 possible points in 2021)
 - □ New applicants must sufficiently describe experience administering federally funded grants, and submit the most recent financial audit, IRS Form 990, and list of current board members.
 - ☐ Should describe how project will reach full operational capacity. New applications that do not demonstrate capacity to carry out project may be rejected by the review team.

2021 Reviewer Comments - Renewal Projects

General comments from the reviewers were:

- Applicants lost points where narratives didn't specifically address questions or provide enough detail within a question.
- Some Project Summaries did not comprehensively describe program, populations being served, &/or services.
- Some Explanations for Objectives 1-A and 1-B lacked detail or explanation missing. Many applicants did not adequately describe:
 - □ Process of assessing clients using the VI-SPDAT or participation in a local CE implementation
 - ☐ Prioritization of clients as outlined in written standards, or participation in a local CE implementation

2021 Reviewer Comments – Renewal Projects (cont'd.)

- Many narratives did not describe how the program helps participants increase employment income and all income
- Many narratives did not describe how the program will increase the number of participants obtaining mainstream benefits
- Applicants with no leavers should have addressed questions and provide information on client progress in meeting objectives 3 and 4
- Some Housing First & Low Barrier charts were competed incorrectly
- Submission of the wrong application
- □ Racial & Ethnicity question not addressed, or no clear plan provided to address barriers

Reviewer Comments – 2021 NEW Projects

General comments from reviewers:

- Applicants lose points where narratives didn't specifically address questions or provide enough detail within a question (scope of project, target population, services, etc.)
- Narratives must demonstrate fair housing and equal access for the proposed project)
- Narratives must demonstrate understanding of housing first and that project will be low barrier
- Narratives must demonstrate understanding of coordinated entry and fully describe how project will assess and prioritize participants, or participate in a local CE implementation
- Narratives must adequately describe supportive services that will be provided, and services should make sense for target population

Reviewer Comments - 2021 NEW Projects (cont'd.)

General comments (cont'd.):

- Project model should demonstrate being housing first and proposed assistance to be provided should be based on needs of each household
- Applicants should demonstrate how participants are connected to ALL mainstream resources (and provide proposed outcomes)
- Documentation for match and leveraging should match amounts throughout the application
- Match and leveraging should be the amounts that will be specifically committed to proposed project
- Line items in the supportive service budget should be fully quantified with detail (real cost for activity X number of households)
- Applicants should discuss how participants will be assisted to obtain/increase income and mainstream benefits (and project outcomes)

Reviewer Comments – 2021 New Project Threshold Issues

Issues/Concerns resulting in a project not being included in the final ranking:

- Joint Component TH-RRH Project design must meet the parameters of project requirements:
 - ☐ Housing first model
 - □ Requirement to combine Transitional Housing (TH) as crisis housing and Rapid Re-Housing (RRH)
 - ☐ Application should demonstrate project would be limited to serving households meeting homeless eligibility requirements.

Reviewer Comments - 2021 New Projects (cont'd.)

Other issues resulting in project Denial for Not Meeting Threshold (Not Scored or Ranked):

- Not demonstrating the capacity to administer grant:
 - ☐ Financial information not submitted
 - ☐ Proposed match and leveraging as 100% volunteer staff
- Incomplete application
- Application submitted for review combined two type of housing into one project
- Application only being submitted in e-snaps
- Target population not demonstrated to HUD Homeless Definition
- Not demonstrating project eligibility (example: narratives describe homelessness prevention)

Reviewer Comments - 2021 New Projects (cont'd.)

Other issues that can result in project Denial for Not Meeting Threshold (cont'd.)

- Insufficient match and leveraging
- Audit findings without the response
- Significant budget errors
- Pre-determined/time-limited assistance per household
- Income requirement for participants
- Proposed projects not demonstrating equal access and fair housing compliance

CoC Program Requirements:

Coordinated Entry Participation Environmental Reviews

Reminder: BoS CoC Coordinated Entry Participation

- •All projects must participate in coordinated entry, and selection of program participants must be consistent with the CoC's Coordinated Entry process
- •BoS CoC-funded projects required to coordinate locally to serve people experiencing homelessness **IN** the Balance of State CoC
- •2021 BoS CoC Coordinated Entry Policy Addendum (Certification)
- •Critical for applicants with projects funded to address homelessness in the Balance of State CoC to target, providing outreach, and participate in local coordinated entry implementation areas (as applicable) in order to reduce homelessness in the Balance of State CoC

Reminder: BoS CoC Coordinated Entry Participation (cont'd.)

- Critical for applicants in non-implementation areas to target, provide outreach, and participate in CES planning to reduce homelessness in the Balance of State CoC
- If being assessed by a DV specific agency, participant information will not be entered into HMIS. De-identified information (DV comparable database client key, VI-SPDAT score, family size, veteran status, and chronicity) will be added to the supplemental prioritization list. Lead agency will follow the standard assessment, prioritization and referral process.

 - DCA will need to submit proposed changes to HUD for review
 - Determines eligible projects, project renewal amounts, and total BoS CoC Annual Renewal Amount (ARA)
 - ARA estimated amount to be determined
 - Renewal applicant responses due by 3:00 pm on Friday, July 1st



2021 HUD NOFO Competition

- As in past years, the application process was a two-step process
 - ☐ Review Application and all required documents for New project ranking
 - Emailed to DCA (with <u>all required</u> attachments)
 - Applications will be scored and ranked by an application review subcommittee
 - ☐ HUD Application in *E-SNAPS*
 - This is required for ALL project applications
 - Must be complete, with all required attachments, by the BoS CoC deadline (TBD)

New Projects

□ New Project Criteria (2021): ☐ Project Applicant in good standing with HUD, DCA, or other ☐ Applicant, subrecipient, project, and participant eligibility ☐ Demonstrate connection to mainstream service systems ☐ Participate/agree to participate in CoC's Coordinated Assessment System AND HMIS (or comparable database) ☐ Must administer programs or activities in the most integrated setting appropriate to the needs of qualified homeless with disabilities ☐ Applicants must commit to following Written Standards and VAWA Policy

Additional BoS CoC NOFO Priorities and Policies

- Proposal Outline for new projects to indicate intention to apply (doesn't commit to applying)
- No late new applications accepted
- New project applications must pass a threshold review to move forward to the scoring portion. Threshold factors include, but are not limited to:
 - ☐ Financial Management Capacity and Experience
 - ☐ Past performance or Open Monitoring Findings, if applicable
 - Match and Leveraging dollars
 - ☐ Use of HMIS (or HMIS comparable system, if a DV provider)
 - ☐ Application is complete or & on time (for new projects)

 - ☐ Certificate of Consistency (Local Approval)

2021 Eligible Project Types

2021 Eligible New Projects

- Funds for new projects typically available through bonus funds available to CoCs that receive a high enough score.
- Possible new projects available as a result of reallocated funding from existing projects (amount unknow)
- In 2021, there were four types of new project applications accepted:
 - ☐ Permanent Supportive Housing (PSH) project
 - ☐ Rapid Re-Housing (RRH) project
 - ☐ Joint TH and PH-RRH Component projects
 - ☐ Supportive Services Only Coordinated Entry (SSO-CE) under DV Bonus only
- Expansions Allowed

Housing First & Low Barrier Projects (Project & CoC Score)

- Low Barrier Entry
 - ☐ Participants are NOT screened out based on barriers for:
 - Having too little or no income
 - Active or history of substance abuse
 - Having a criminal record (w/exception of state-mandated restrictions)
 - Having a history of victimization
 - ☐ 100% BoS Applicants committed to being Low Barrier
- Service Participation Requirement
 - ☐ Participants are NOT terminated for:
 - Failure to participate in supportive services
 - Failure to make progress on a services plan
 - Loss of income or failure to improve income
 - Any other activity not covered in a lease agreement typically found for unassisted persons
 - ☐ 100% BoS Applicants Committed to being Housing First

Eligible Populations

Definition of Homelessness (Categories 1 & 4)

The CoC program specifically targets/prioritizes homeless persons who:

- □ Category 1: Individuals and families who lack a fixed, regular, and adequate nighttime residence, meaning:
 - ☐ Has a primary nighttime residence that is not meant for human habitation; or
 - □ Is living in a publicly or privately operated shelter designated to provide temporary living arrangements (including congregate shelters, transitional housing, and hotels and motels paid for by charitable organizations or by federal, state and local government programs); **or**
 - ☐ Is exiting an institution where she/he temporarily has resided for 90 days or less and who resided in an emergency shelter or place not meant for human habitation immediately before entering that institution.
- □ Category 4: individuals and families who:
 - Are fleeing, or are attempting to flee, domestic violence ("Domestic Violence" includes dating violence, sexual assault, stalking, and other dangerous or life-threatening conditions that relate to violence against the individual or family member that either takes place in, or him or her afraid to return to, their primary nighttime residence (including human trafficking);
 - ☐ Has no other residence; and
 - ☐ Lacks the resources or support networks to obtain other permanent housing

Populations Served Through Continuum of Care

Homeless Individuals & Families

- Originally from the streets or emergency shelters (or as expanded by NOFO).
- □ Homeless Verification A household is homeless if you can prove with adequate documentation.
- All families served by new PSH or RRH projects MUST meet HUD definition of homelessness (or as expanded by NOFO) and agencies MUST complete/provide homeless verification on ALL people served.
- Example of Documentation format on DCA ESG web page at: https://www.dca.ga.gov/node/1922/documents/10
- □ Families with children include ALL families with children.
- *Under the CoC Program, households with children may not be categorically excluded from any project based solely on the basis of their familial status.
- Equal access.

Examples of Persons NOT Eligible (PSH)

- Persons with resources for housing
- □ In housing paying excessive rent, in substandard or overcrowded housing
- □ Living long-term with immediate family, relatives or friends
- □ Living in a congregate living facility (other than a shelter)
- □ Living in a hospital or institution (for > 90 days) where the institution has a policy that requires housing placement at discharge
- Youth or adults in state custody

All projects must participate in coordinated entry, and selection of program participants must be consistent with the CoC's Coordinated Entry process.

Examples of Persons NOT Eligible (RRH and Joint TH/RRH)

- Persons housed or with resources for housing
- In housing paying excessive rent, in substandard or overcrowded housing
- □ Living long-term with immediate family, relatives or friends
- □ Living in a congregate living facility (other than temporary shelter or transitional housing for homeless)
- □ Living in a hotel/motel (unless paid for by charitable organization or government program)
- Living in a hospital or institution (for > 90 days) where the institution has a policy that requires housing placement at discharge
- Youth or adults in state custody

All projects must participate in coordinated entry, and selection of program participants must be consistent with the CoC's Coordinated Entry process

Chronic Homelessness & Dedicated Plus

Final Definition of Chronically Homeless (Amends 24 CFR 91.5 and 24 CFR 578.3)

Chronically Homeless means:

- (1) A "homeless individual with a disability," who:
 - ☐ Lives in a place not meant for human habitation, or emergency shelter; and
 - ☐ Has been literally homeless continuously for at least 12 months or on at least 4 separate occasions in the last 3 years (combined occasions must total at least 12 months)
 - Occasions separated by a break of at least 7 nights
 - Stays in an institution of fewer than 90 days do not constitute a break
- (2) An individual who has been residing in an institutional care facility for fewer than 90 days (meeting all criteria in paragraph (1), before entering the facility; or
- (3) A family with an adult head of household (or if there is no adult in the family, a minor head of household) who meets all criteria in paragraphs (1) or (2) of this definition, including a family whose composition has fluctuated while the head of household has been homeless.

*Seeks to ensure that persons with highest needs are prioritized for permanent supportive housing

^{*}Definition of "chronically homeless" provides a way to prioritize people with longest histories of homelessness and most severe needs

*Coalso to approve that persons with high set people are prioritized for persons at supporting housing.

New Project Threshold

- Agency meets HUD's eligibility criteria
- Agency demonstrates adequate capacity to carry out grant (with proper documentation).
- Project meets eligible costs or activities requirements.
- Project sufficiently demonstrates eligible populations will be served.
- Project shows required match & sufficient commitments for leveraging to implement project.
- Agency does not have serious compliance or performance issues on current projects.
- Project demonstrates adequate impact or cost effectiveness.
- Project meets HUD Joint TH & PH-RRH Component Minimum Standards or SSO-CE DV Bonus Minimum Standards
- Project for Balance of State CoC's 152 county jurisdiction

Additional BoS CoC N()F() Priorities and Policies (continued)

Joint Component TH & PH-RRH additional threshold factors included, but not limited to: ■ Not intended to replace transitional housing projects ☐ Provide crisis housing with financial assistance and supportive services based on client need ☐ Have both TH & RRH components, where RRH budget is two thirds of housing ☐ Target and prioritize people with higher needs and most vulnerable ☐ Target people in unsheltered locations or homeless youth ☐ Demonstrate proposed area in not covered by crisis housing and have a street outreach team, or be in an area where coordinated entry planning is occurring

Project Quality (HUD) NOFO)

- Whether type and scale of housing proposed will fit the needs of program participants

- *Whether proposed project has a specific plan to coordinate and integrate with other mainstream health, social services, and employment programs and ensure that program participants are assisted to obtain benefits from mainstream programs for which they may be eligible.
- Whether program participants are assisted to obtain and remain in permanent housing in a manner that fits their needs
- □ Whether proposed Joint TH-RRH Component projects will provide enough rapid rehousing assistance that at any given time a participant may move from TH to permanent housing (2 times the resources for RRH versus TH).
- Joint TH-RRH Component projects are required to adhere to a housing first model as defined in the NOFO

- Review narratives for completeness
- Have someone else read your application before submission
- Double check all attachments
- Don't wait to ensure access to e-snaps
- Don't wait until the last minute to complete e-snaps application
- Questions specific to e-snaps' functionality must be sent to HUD e-snaps@hud.gov
